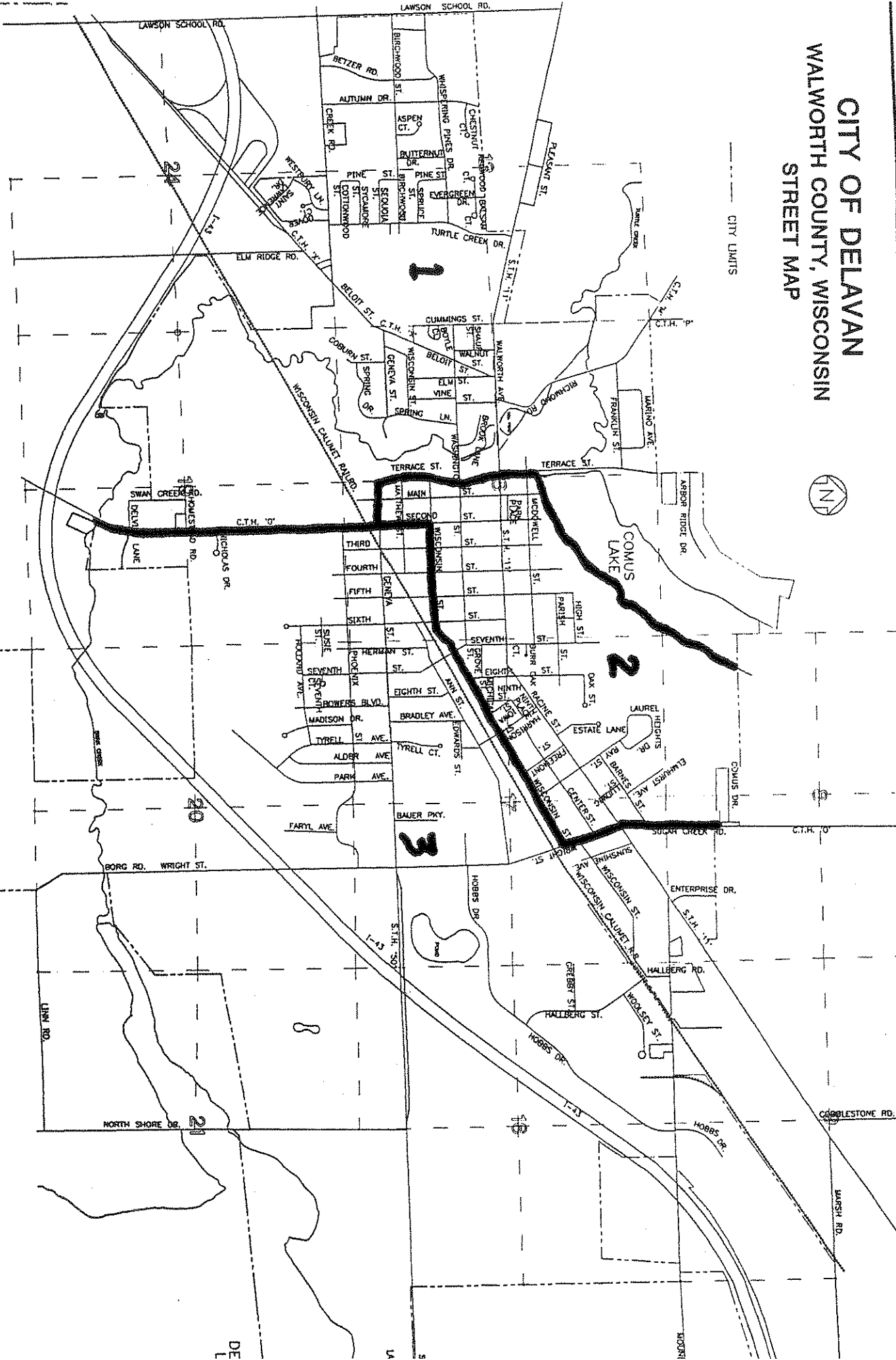


CITY OF DELAVAN WALWORTH COUNTY, WISCONSIN STREET MAP
